Registering to Practise in BC

To work as an occupational therapist or use title, you must register with the College of Occupational Therapists of BC (COTBC), also known as the "OT College". Registration is also required prior to attending any pre-employment orientation or training. Get started as soon as you can!

Before applying to practise in BC you must complete ACOTRO's Substantial Equivalency Assessment System (SEAS) process.
